The committee reviewed the effectiveness of the anti-ragging affidavits and awareness programmes, concluding that these initiatives significantly contributed to maintaining a safe and supportive campus environment. The assessment of the awareness programmes revealed strong student participation and positive feedback, highlighting the success of these initiatives in promoting a respectful campus culture. Looking ahead, the committee discussed strategies for the upcoming academic year, including the introduction of new interactive sessions and enhancements to existing programmes to further engage students in the college's anti-ragging efforts.
