ORDER

The application submitted vide paper read (1) above, for starting new Unaided Self financing Arts & Science College under the name & style, 'Viswajyothi College of Arts & Applied Sciences, Komanad, Vengoor, Kunnathunad, Perumbavoor' with Unaided courses namely, BBA, BCA, B Com Model II (Vocational: Finance & Taxation), BA English Literature, Communication & Journalism Model III (Triple Main) and BA Animation & Graphic Design, for the academic year 2014-15 was considered by the University and Inspection Commission was constituted vide U O read (2) above, to assess the instructional & infrastructural facilities provided by the educational agency to start the proposed College with courses mentioned. The recommendation of the University to start the proposed college with abovementioned courses was forwarded for the views/NOC of Government of Kerala vide paper read (3) above.

The Government of Kerala vide paper read (4) above, issued NOC for starting new Unaided Self financing Arts & Science College under the name & style, 'Viswajyothi College of Arts & Applied Sciences, Komanad, Vengoor, Kunnathunad, Perumbavoor' with Unaided courses namely, BBA (40 seats), BCA (30 seats), B Com Model II (Vocational: Finance & Taxation) (40 seats), BA English Literature, Communication & Journalism Model III (Triple Main) (24 seats) and BA Animation & Graphic Design (30 seats), during the academic year 2014-15.

In the light of the NOC issued by Government of Kerala, the Syndicate Standing Committee on Affiliation, vide paper read (5) above, resolved to grant provisional affiliation to the new Unaided Arts & Science College 'Viswajyothi College of Arts & Applied Sciences, Komanad, Vengoor, Kunnathunad, Perumbavoor' with the following courses, during the academic year 2014-15.

The Hon'ble Vice Chancellor, exercising powers u/s 3.10(17) of Mahatma Gandhi University Act, 1985, approved the above mentioned recommendation of the Syndicate Standing Committee on Affiliation.

Sanction has, therefore, been accorded for starting a new Unaided Self financing Arts & Science College 'Viswajyothi College of Arts & Applied Sciences, Kombanad, Vengoor, Kunnathunad, Perumbavoor', with the above mentioned courses, during the academic year 2014-15.

Provisional affiliation is granted subject to the following conditions:

1. The provisional affiliation is granted initially for a period of one academic year only.
2. The Management shall prepare and present the students in accordance with the laws of the University for the examination and as per the approved scheme and syllabus of the University in the subjects concerned.
3. As per G.O read as (4) above, the Educational Agency shall set apart 50% of the seat of the courses being filled up by the Government or such authority determined by the Government and the remaining 50% filled up by the Educational Agency on the basis of merit.

4. The Management shall collect the Tuition Fee and remit the fees due to the University as follows:

a)

- b) Students' Insurance Premium @Rs.10/- per student per year
- c) Students' Welfare fund @Rs.20/- per student per year.
- d) University Union Fee @ Rs.50/- per student per year
- e) Sports Affiliation Fee @Rs.150/- per student per year to be utilized in the ratio 50:50 by the University and the College.
- f) Students Affiliation Fee @ Rs. 300/- each for U.G Courses on one time basis shall be

- collected at the time of admission from all students and shall be remitted to the University with in Fifteen days after closing of the Admission.
- g) Collection of Annual Administration Fee from the students under any circumstances is not permitted.
5. Changes (if any) in the rate of Tuition Fee will be intimated later.
 6. The Educational Agency shall remit Rs. 2,00,000/- (Rupees Two Lakhs only) in Mahatma Gandhi University Fund towards Initial Affiliation Fee for new college.
 7. The Educational Agency shall furnish a Financial Guarantee of Rs. 3,00,000/- (Rupees Three Lakhs only) as provided in Mahatma Gandhi University Statutes, 1997, by way either of the following:
 - a) Cash Deposits
 - b) Fixed Deposit in the State Bank of India or in any of the Nationalized Banks, having Acquisition and Transfer of Undertaking. The Receipt being endorsed in the name of the Finance Officer, Mahatma Gandhi University.
 - c) Government Securities
 - d) Saving Certificates, National, Postal or Defence Bonds in favour of the Finance Officer.
 - e) Mortgage of the title deed of immovable property other than the College sites, buildings/hostels where such mortgage is permitted under any law for the time being in force.
 8. The Educational Agency shall furnish an undertaking in a stamp paper worth Rs. 100/- to the effect that it will abide by the rules, regulations and instructions issued by the University, State Government, Regulatory Body regarding the admissions to the courses from time to time.
 9. The College shall submit the list of students admitted and remit the fees due to University within 15 days after closing admission.
 10. The Educational Agency shall furnish the financial guarantee within one month from the date of sanctioning affiliation.
 11. Non-compliance with any of the above mentioned conditions will result in the withdrawal of the affiliation without any notice.
